
FIRE ACCESS & WATER SUPPLY PLAN SHEET NOTES

- 1. PRIOR TO FINAL OCCUPANCY, THE BUILDING SHALL BE PROVIDED WITH A 6" PERMANENT ADDRESS PLACARD AT EACH ENTRANCE.
- 2. CONTRACTOR TO VERIFY THAT THE (4) FIRE HYDRANTS PROVIDING COVERAGE TO BUILDING 300 IS CONFIGURED AS FOLLOWED: EACH HYDRANT SHALL HAVE A 5" STORZ ADAPTER W/ NATIONAL STANDARD THREADS INSTALLED ON THE 4-1/2" INCH FIRE HYDRANT. THE ADAPTER SHALL BE CONSTRUCTED OF HIGH-STRENGTH ALUMINUM
 - ALLOY, HAVE A TEFLON COATING ON THE SEAT AND THREADS, AND USE A RUBBER GASKET AND TWO SET SCREWS TO SECURE IT IN PLACE. THE ADAPTER SHALL BE PROVIDED WITH AN ALUMINUM ALLOW PRESSURE CAP. THE CAP SHALL BE ATTACHED TO THE HYDRANT BARREL OR STORZ ADAPTER WITH A CABLE TO PREVENT THEFT OF THE CAP. ADAPTER SHALL BE HARRINGTON HPHA50-45NHWCAP OR EQUAL AS APPROVED BY GRESHAM FIRE.
- 3. CONTRACTOR TO VERIFY THAT BLUE REFLECTIVE MARKERS ARE INSTALLED ADJACENT AND TO THE SIDE OF THE CENTERLINE OF THE ACCESS ROADWAY ON WHICH FIRE HYDRANTS ARE LOCATED.
